On Wednesday, May 24, 2023 Jessica Dorado of 298 Thistle Street came to the Mesquite Police Department lobby and requested to file a citizen's complaint. Jessica expressed a desire to speak with a supervisor about filing a complaint against one of the Mesquite Police Department volunteers.

At approximately 0914 hours, Mesquite Police Department, Administrative Assistant John Bottoms, #6209 was assigned to receive the complaint information.

Administrative Assistant John Bottoms responded to the police department lobby and greeted Ms. Dorado. Bottoms escorted her to an interview room adjacent to the police lobby. Ms. Dorado was identified by her Nevada driver's license, #1902963373, Jessica Dorado, DOB: 12/04/1988.

Ms. Dorado described an incident that occurred the day before while attending the Virgin Valley High School graduation parade. Ms. Dorado said she, her husband and two minor children were at the parade to support a family member who was participating in the graduation parade. At the conclusion of the parade they began to leave the area, when a female wearing a yellow and orange reflective traffic vest with the words Police Volunteer approached them and told them to pick up their trash. Ms. Dorado said there was a Maverik gas station plastic drink cup (Icee) on the ground adjacent to the area they were standing. Ms. Dorado said the drink had been abandoned by someone else and had completely melted. Dorado told the volunteer that it wasn't hers or any of her families drink.

Dorado said she began to walk away when the volunteer again told them to pick up their trash. Dorado turned back and reiterated that it wasn't theirs. Dorado said the volunteer then used profanity in telling her to pick up her trash. Dorado said the volunteer said, "Pick up your fucking trash." Dorado said she immediately replied to the volunteer that it wasn't hers and that her comments were inappropriate. Dorado said, the volunteer approached the drink cup, kicked it over splashing it onto her feet and said again "pick up your fucking trash."

Dorado said the volunteer continued to use profanity and that's when her husband, Eduardo spoke up and replied back to the volunteer also using profanity and told her that it wasn't their fucking trash and that they weren't picking it up. Dorado said some additional words were expressed back and forth and then shortly after a police volunteer truck pulled up and the female police volunteer walked away from them toward the truck.

Dorado took out her cellular telephone and captured an image of the volunteer who was wearing a reflective traffic vest, blue polo style shirt with a Thin Blue Line Flag on the sleeve and dark colored cargo style pants. Dorado said she only took the photograph to document who the volunteer was. Dorado said when the volunteer realized she was being photographed, she began raising her hand in an effort to block or conceal her face. Bottoms reviewed the image and recognized the Police volunteer as Judy Edgington. Bottoms took a screenshot of the image on Dorado's cell phone.

Dorado said she is a lifelong resident of Mesquite and has never received this type of treatment from a city employee or any representative of the police department. Dorado said in addition to her immediate family there were other family members nearby and other witnesses at the parade who observed this volunteers behavior and comments.

Dorado said she was angered by the inappropriate comments and the volunteer's rude behavior so she decided to create a social media post about the incident later than evening. After posting the incident she was encouraged to share the incident and her concerns with the police department. Dorado said she learned that others who saw her social media post (Facebook) shared the story on their individual profiles. Dorado was asked if anyone in the comments section indicated they witnessed the incident or captured it in any recordings. Dorado had not observed any followers making that known, but indicated she would share that information with the police department if it was provided to her. Bottoms collected a screenshot of the Facebook post.

Dorado said she wanted to file this complaint because she feels the actions of the volunteer were inappropriate and someone needs to address the comments, use of profanity and behavior of the volunteer. Dorado thought the volunteer kicking the cup of liquid over and splashing it on her was very unprofessional. Dorado was asked what she hoped would occur as a result of her complaint. Dorado would like to receive an apology and preferred it to be a public apology.

On Thursday, May 25, 2023 at 10:26 am Administrative Assistant John Bottoms received a voicemail message from telephone number (435)862-0928, Jessica Dorado who reported that a witness to her incident with the Mesquite Police volunteer had contacted her from her social media post. Jessica provided the witnesses name and telephone number in the voicemail.

At 1:45 pm, John Bottoms telephoned the witness, Nubia Nunez of 832 Whitney Lee Ln. at telephone number 702-613-6127. Bottoms spoke with Ms. Nunez who reported that she had been in attendance at the Virgin Valley High School parade on Tuesday afternoon and witnessed an interaction between a police volunteer and Jessica Dorado.

Ms. Nunez said she was standing nearby and at the conclusion of the parade, heard the police volunteer telling Jessica and her family members to pick up their trash. Nunez said she heard the volunteer say this a few times and each time Jessica and the man with her, reply saying that it wasn't their trash. Nunez said the volunteer walked over to the cup on the ground and intentionally kicked it over spilling it on Jessica's feet. Nunez said she did not hear the volunteer using any profanity.
