Incident Report:

On July 30th, 2023 I Officer Shumway was on duty at the Mesquite Detention Center. At approximately 2150 hours Officer Magadan was at the Mesquite Detention Center assisting with another inmate. Officer Magadan walked over to cell 101 and saw inmate Vonna Johnson wrapping a white sheet around her neck. Both Officer Magadan and I entered cell 101 and asked Vonna what she was doing. Vonna said she was doing nothing and denied that she was wrapping a sheet

around her neck. Both officer Magadan and I escorted Vonna to safe cell 102 where she complied and voluntarily stripped all of her clothing and put on a suicide smock. Vonna was told because she was trying to harm herself she will need to stay the remainder of her time in safe cell 102 until she is cleared to be moved elsewhere.

Once Vonna was in safe cell 102 she made her hand look like a gun and put it to her head as if shooting herself and stated: "when i get out of here the brains are going." I told her that would not be something good to do. She stated, "you know what, i just don't give a shit anymore."

Vonna complied and will be placed on suicide watch until cleared to be released from 102.
