Incident Report:

On 3/23/25 at approximately 03:23 hours I, Officer Magadan was dispatched to the area of 100 E. Pioneer Blvd in Mesquite Nevada for a suspected DUI driver. The caller stated they observed a red Dodge Ram pick up truck with Nevada license plates 019 A48 swerving on the road. The vehicle was last seen going into the Virgin River Casino Parking lot.

Upon arrival I observed a vehicle fitting the same description and license plate. I followed behind it in lane two as it drove south on Pioneer Blvd toward Sandhill Blvd. I observed the vehicle hit the curb under the I15 over pass and then cross over the white dotted lines. I activated my emergency lights and conducted a traffic stop. The driver drove into the parking lot of 333 Sandhill Blvd. I approached the driver. I identified him and told him the reason for the stop. The driver was identified as Ulises RODRIGUEZ (DOB:3/16/82). RODRIGUEZ had red blood shot watery eyes and smelled of alcohol. I asked RODRIGUEZ how much he had to drink and he stated he wasn't drinking. RODRIGUEZ stated he didn't have a drivers license and handed me his Nevada drivers license. I ran his information and dispatch informed me RODRIGUEZ had revoked drivers license for DUI. I returned to the vehicle and asked RODRIGUEZ again how much he had to drink and he stated he had one beer.

I conducted field sobriety test (FST) to see if he was capable of driving a motor vehicle. I utilized the Mesquite Police Department Standardized Field Sobriety Checklist.

RODRIGUEZ stated "no" to all the medical questions. When asked what have you been drinking? RODRIGUEZ stated "beer." I asked RODRIGUEZ what time did he have that beer and he stated "an hour ago." I asked RODRIGUEZ without looking at a watch or clock what estimated time did he think it was? RODRIGUEZ stated "11:00 PM." The actual time was approximately 3:15 AM. We conducted the rest of

the test and the results are as follow:

Horizontal Gaze Nystagmus (HGN)

RODRIGUEZ had lack of smooth pursuit in both eyes. Distinct and sustained nystagmus in both eyes and onset of nystagmus prior to 45 degrees. The result of this test shows a BrAC of .08 or higher.

Walk and Turn

RODRIGUEZ stopped walking on the first 1-9 and return 1-9. RODRIGUEZ missed heel to toe on step 4,5,6,7 of the first 1-9. RODRIGUEZ missed heel to toe on 3,4,5, and stepped off line at 6. RODRIGUEZ miscounted steps both times. RODRIGUEZ raised his arm to keep his balance and conducted an improper turn. The result of this test shows RODRIGUEZ may be impaired.

One Leg Stand.

RODRIGUEZ chose to raise his right foot. RODRIGUEZ miscounted his steps and his last number was 12. RODRIGUEZ continued to use his arm for balance. He swayed side to side and put his foot down multiple times. The result of the test shows RODRIGUEZ may be impaired.

Preliminary Breath Test (PBT)

RODRIGUEZ gave me a breath sample using the PBT and the result was .235 BrAC. Officer Hughes assisted with the impounding the vehicle. I transported RODRIGUEZ to MDC. I read RODRIGUEZ the implied consent and he chose breath. I observed RODRIGUEZ for 15 minutes with nothing to report. I utilized the Intoxilyzer 8000. RODRIGUEZ gave me two breath samples. The first was .254 BrAC and the second .265 BrAC. Correction requires anyone who blows a .250 or higher to be medically cleared. I transported RODRIGUEZ to Mesa View Regional Hospital. RODRIGUEZ was evaluated and transported back to MDC.

I completed a DP 45 form and the Intoxilyzer 8000 Checklist. Mesquite Police FST sheet was added to the file along with the Intoxilyzer 8000 result slip. RODRIGUEZ was not given a temporary license due to the obvious fact his license was revoked.

During an inventory search an open container of Modelo's was found in the vehicle. Anytime Towing impounded the vehicle. RODRIGUEZ was given an impound report to his property.

RODRIGUEZ was charged with the following on citation MPD084035 DUI (2nd) (NRS 484C.400.1b). RODRIGUEZ was arrested on 11/24/24 for a second DUI out of Las Vegas Metropolitan Police Department. However; at this time there was no conviction listed. The first DUI was on 2/21/22.
