Arrest Report:

On Sunday, March 23, 2025 at approximately 1500 hours I, Officer S. Ruth, was investigating a Grand Larceny when I learned a male, Tristyn Williams, was given the stolen property (see incident 250321017 for additional information). During my interview with the juvenile theft suspect, Antonio Gallegos, he told me he took the stolen bike to a nearby skate park and gave it to Tristyn, stating he helped him put it in the back of Tristyn's truck. Antonio stated he was unaware of the current location of the bike. The bike is identified as an olive green Fezzari mountain bike, with custom red handle grips and a marine corps sticker on the frame. The value of the bike is \$6,000.

Sergeant J. Stout and Officer S. Vent assisted me with the investigation and located Tristyn at the Mesquite Skate Park, located at 10 Woodbury Lane. Sergeant Stout asked Tristyn if he knew where the bike was. Tristyn told Sergeant Stout that Antonio brought the bike to the skate park on Friday March 21, rode it around for a short while, and then left it abandoned near the tables. Tristyn stated he last saw the bike near the tables when he left the park at approximately 1900 hours. Tristyn told Sergeant Stout that he returned the following morning, Saturday March 22, at around 1000 hours, and the bike was no longer there.

I spoke again to Antonio and he was adamant that he put the bike in Tristyn's truck and that Tristyn drove away with it. I contacted Mohave County Deputy N. Rosenblum, sent him a picture of the stolen bike, and requested he attempt to contact Tristyn's mother, Brandy Williams, and confirm if he brought the bike to their home located at 3804 S Mokiah Way, Littlefield Arizona. Deputy Rosenblum called me a short time later and stated nobody answered the door at Tristyn's home but he was able to see, in plain sight, the stolen bike on Tristyn's property. Deputy Rosenblum was able to identify the bike by the custom red handlebars, the unique olive color, and several stickers.

After speaking to Deputy Rosenblum, and confirming the stolen bike was at Tristyn's home, Sergeant Stout and Officer M. Diaz returned to the skate park and spoke with Tristyn again. Sergeant Stout advised Tristyn of his Miranda Rights and Tristyn agreed to answer his questions. Sergeant Stout asked again if Tristyn knew where the stolen bike was and he again denied knowing it's location. Sergeant Stout then told him a Deputy had confirmed the bike was at Tristyn's house and Tristyn stated "I will give it back" to the owner. Sergeant Stout placed Tristyn under arrest for Receiving/Transferring Stolen Property. While being placed in handcuffs, Tristyn uttered "the guy can go get his bike, I give him permission". Sergeant Stout asked Tristyn why he lied about the bike during the first conversation and Tristyn did not respond.

Officer M. Diaz placed Tristyn in her patrol unit and transported him to the Mesquite Detention Center where he was held and later transported to the Clark County Detention Center and booked on the following:

NRS 205.275.2C, Receive/Transfer Stolen Property value greater than \$5,000 less than \$25,000.
