Incident Report:

On 03/25/25 at approximately 1351 hours I, Officer S. Ruth was dispatched to a two vehicle accident at the intersection of N Sandhill Blvd and E Old Mill Rd; Mesquite, NV 89027. Details of the call stated two vehicles hit head on and one of the vehicle had air bags deployed.

Upon arrival, I observed a silver Toyota 4Runner bearing UT plate 0K8MT (vehicle 1) occupied by an adult male driver, identified as Worster, Randy DOB 01/05/62 via UT DL (driver 1). I also observed a gray 2000 Saturn SL1 bearing NV plate 250EXZ (vehicle 2) with its airbags deployed, occupied by an adult female driver, identified as Allen, Donna DOB 11/09/38.

Traffic cameras showed Worster was traveling south on N Sandhill Blvd and was in the left turn lane with a flashing yellow traffic signal. Allen was traveling north on N Sandhill Blvd and had a green light to continue straight. Worster made a left turn onto E Old Mill Rd on a flashing yellow light and Allen's vehicle collided with the passenger side doors of Worster's Toyota.

Allen's Saturn had significant damage to the front bumper and her airbags were deployed. Medical arrived on scene, but Allen declined any medical attention. Worster also declined medical attention.

Allen's vehicle was towed from the scene by Anytime Towing due to being disabled. Worster's vehicle was driveable and remained in his possession.

Due to the fact Worster failed to yield right of way at a controlled intersection while making a left turn, he was issued citation #MPD085029 per NRS 484B.253.

A State of Nevada Form 5 was completed for this accident.
