On Wednesday 03/26/25 at approximately 1900 hours I, Officer Stratton, responded to a residence located at 264 Mimosa Way reference a fraud call.

I spoke with the reporting person, Kathleen Roberts, and obtained the following information.

Kathleen said she noticed a fraudulent charge on her America First Credit Union (AFCU) checking account this morning for \$68.50 and another for an ATM fee of \$1.50. Both charges were made on 03/22/25 at the ATM located at the Green Valley Grocery convenience store located at 910 West Mesquite Boulevard. Kathleen had a print out of her bank statement and the transactions showing for her bank card ending in 9602. The statement did not show a transaction time.

Kathleen said she already reported it to AFCU fraud department and disputed the charge but had not been reimbursed the money. Kathleen canceled that card and had it replaced with a new one. Kathleen reported she has never used her card at an ATM before and still has the card in her possession. She was unsure how another person would be able to make a withdrawal with her card when she still had possession of it.

I took the statements and information to the convenience store where the ATM withdrawal was made. I spoke with the manager, Elizabeth Soper, over the phone. She said she would attempt to find the transaction on the ATM and gather any recorded footage she could tomorrow on the store's surveillance cameras.

At this time there is no further information.
